A Scheduled Meeting and Public Hearing of the Troup City Council was held Monday August 26, 2019 at 6:30 pm at the Cameron J-Jarvis Troup Municipal Library located at 102 S. Georgia, Troup, Texas. Mayor Joe Carlyle called the meeting to order at 6:36 p.m. noting all Council members were present with the exception of Chip Richardson and Jeff Hale.

Nelson Darden led the invocation.

Nelson Darden led the Pledge of Allegiance.

Mayor Joe Carlyle – Item 4 Consider approval of the minutes from the Regular Scheduled Meeting July 15, 2019. Councilperson Brandi Barton made the motion to approve the minutes for July 15, 2019. Councilperson Carole Wilson seconded the motion and the motion carried unanimously.

Mayor Joe Carlyle – Item 5 Citizen Comments- Brief Comments concerning non-Agenda items. No comments were made.

Mayor Joe Carlyle – Item 6 Review and consider the city financial report for the month of July 2019. Councilperson Nelson Darden made the motion to approve the financials from July 2019. Councilperson Brandi Barton seconded the motion and the motion carried unanimously.

Councilperson Carole Wilson made the motion that following the Public Hearing, the fiscal year 2019-2020 budget be submitted for consideration for adoption by the City Council at the meeting to be held on Monday, September 16, 2019. Councilperson Nelson Darden seconded the motion and the motion carried unanimously.

Mayor Joe Carlyle – Item 13 Discuss and consider authorizing the publication of the Notice of Tax Revenue Increase form 50-198. Councilperson Nelson Darden made the motion to authorize the publication of form 50-198. Councilperson Brandi Barton seconded the motion and the motion carried unanimously.

Jarvis Troup Municipal Library. Councilperson Brandi Barton made the motion to accept the Library Board Recommendation for the appointment of Jan Singletary, Shannon Capps and Gene Whitsell with their term expiring in 2021. Councilperson Carole Wilson seconded the motion and the motion carried unanimously.

City Manager Gene Cottle told Council that this would be for the pipe bursting procedure.
